

- 2. Connect the USB-Link via its Micro-USB plug to PC, Mac or smartphone using one of the dedicated USB cables:
- USB-A cable for PC/Mac
- Micro-USB or USB-C cable for smartphones

Notice Micro-USB cable has the same connectors on both sides However, it is very important to connect the USB-Link and

smartphone to appropriate ends of the cable. Otherwise, it will not work.
